

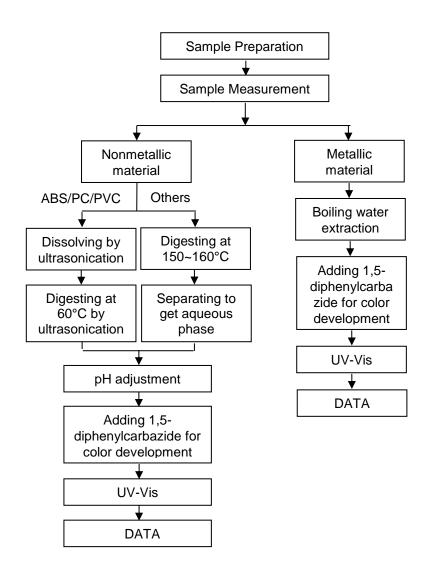

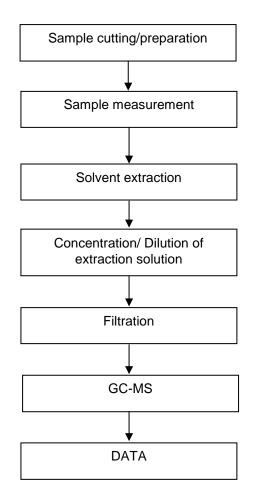



Phthalates Testing Flow Chart


